## SUMMARY ANNUAL REPORT FOR MIDWEST OPERATING ENGINEERS RETIREE WELFARE PLAN

This is a summary of the annual report for Midwest Operating Engineers Retiree Welfare Plan, EIN 37-1752023, for the year ended December 31, 2022. The annual report has been filed with the Employee Benefit Security Administration as required under the Employee Retirement Income Security Act of 1974 (ERISA).

The Board of Trustees of Midwest Operating Engineers Retiree Welfare Plan has committed itself to pay all claims incurred under the terms of the plan.

## **Basic Financial Statement**

The value of plan assets, after subtracting liabilities of the plan was \$981,035,650 as of December 31, 2022 compared to \$1,024,949,806 as of January 1, 2022. During the plan year, the plan experienced a decrease in its net assets of \$43,914,156. This decrease included unrealized appreciation or depreciation in the value of plan assets; that is, the difference between the value of the plan's assets at the end of the year and the value of the assets at the beginning of the year or the cost of assets acquired during the year. During the plan year, the plan had total income of \$91,172,000 including (but not limited to) employer contributions of \$156,549,616, participant contributions of \$36,163,531 and losses from investments of \$138,769,830.

Plan expenses were \$153,267,417. These expenses included \$5,772,172 in administrative expenses, \$147,495,245 in benefits paid to or for participants and beneficiaries.
