

SUMMARY ANNUAL REPORT FOR  
MIDWEST OPERATING ENGINEERS  
RETIREMENT ENHANCEMENT FUND

This is a summary of the annual report for Midwest Operating Engineers Retirement Enhancement Fund, EIN 51-0669630 for the year ended May 31, 2024. The annual report has been filed with the Employee Benefit Security Administration as required under the Employee Retirement Income Security Act of 1974 (ERISA).

Basic Financial Statements

Benefits under the plan are provided by Trust. Plan expenses were \$18,014,119. These expenses included \$469,860 in administrative expenses and \$17,544,259 in benefits paid to participants. A total of 16,506 were participants in or beneficiaries of the plan at the end of the plan year.

The value of plan assets, after subtracting liabilities of the plan was \$637,068,317 as of May 31, 2024, compared to \$486,571,106 as of June 1, 2023. During the plan year, the plan experienced an increase in its net assets of \$150,497,211. This increase included unrealized appreciation or depreciation in the value of plan assets; that is, the difference between the value of the plan's assets at the end of the year and the value of the assets at the beginning of the year or the cost of assets acquired during the year. During the plan year, the plan had total income of \$168,511,330 including (but not limited to) employer contributions of \$70,104,409, participant rollover contributions of \$816,381, earnings from investments of \$96,895,499 and \$695,041 of other income.
