Johan Pena, a union avoidance consultant from Miami, was hired through the Oklahomabased Labor Relations Institute in September (along with consultants Amed Santana and Jorge Sandoval) to convince warehouse, production, maintenance, and other employees of Henry Broch Foods in Waukegan, IL not to unionize with the Teamsters. Phil Wilson, head of the LRI, doesn't specify in his report which **Teamsters** local his firm was specifically hired to target. Wilson describes the organizing campaign as "pre-petition," meaning the union hasn't yet filed a petition with the National Labor Relations Board for a union election and I don't see any record of this organizing drive through the National Labor Relations Board either. I do see there is an unfair labor practice charge pending against Henry Broch Foods, accusing the employer of unlawful interrogation. Sadly, that's not unusual. Charging parties include both the **Teamsters** Local 301 and Teamsters Joint Council 25 in Illinois. According to the petition, the employer agreed to pay the LRI a rate of \$425 per hour "plus reasonable travel expenses" for the job, which began Sept. 19, 2024 and is identified by Wilson as "ongoing."

Going deeper: Henry Broch Foods, first established in 1941, is a food processing plant that merged with the U.K.-based JDM Food Group in 2023 to form the parent company, Jardins and Broch. Pena, the Miami-based consultant, has also been hired by the likes of **Knott's Berry Farm** in California, William Sonoma, and Tate's <u>Bake Shop</u> up in New York — a bakery that was accused at one point of threatening to deport their undocumented workers for any pro-union sentiment ahead of their union election, according to the Gothamist (Pena isn't the only persuader Tate's hired — members of the <u>Flores family</u> were also hired through the Labor Relations Institute to handle Tate's union avoidance strategy).


